# **COVID-19 updates**

During the current COVID-19 pandemic NSCMIRTP staff continue to work a blended model of approximately 1/2 time in office and 1/2 time remotely. All public health guidelines are being followed. We ask that anyone who requires in person assistance to please book an appointment. Where possible these will be conducted virtually.



NSCMIRTP is also working to provide regular <u>COVID-19 updates</u> so please check out our website to keep yourself informed on guidelines for who can access care, immunization programs, research and other resources for healthcare providers.

# **Changes to Dues Refund and Proration of Dues**

NSCMIRTP are making changes to the current dues refund policy, and proration of dues. Both of these will become effective Jan 1st 2022. At that time refunds of dues will no longer be offered after Jan 1st of each year.



**Dues Refund** –This means individuals who renew in the fall but resign prior to Jan 1st can still receive a full refund but those resigning after Jan 1st of each year will no longer be eligible for partial refund of dues.

**Proration of Dues**- Additionally effective Jan 1st 2022 dues will only be prorated May 1st of each year. This means those seeking licenses between Jan 1st and April 30th each year will pay the full annual dues which is \$450. Those seeking licensing between May 1st and Dec 31st will pay \$225. The proration will align with the principle graduation of students from Dalhousie University. Given the discounted fees incorporated into the prorated dues the Nova Scotia New Grad discount will be discounted.

These changes are being made to help streamline administrative processes and costs and better align with standard regulatory practices.

### **Currency Hours Change**

The College has received several inquires asking when the College currency hours will be applied and how they will be audited. The full <u>currency hours policy</u> and the <u>alternative</u> <u>assessment for currency</u> policy can be viewed through the provided links. All registrants are expected to meet currency requirements by Dec 31st of 2021. Currency hours will be self reported during renewal each year. Those registrants selected for audit of their CPD will also have their currency hours audited.



#### **Informal Audits**



NSCMIRTP is performing several informal audits to ensure accuracy of registrant data.

**Professional Liability Insurance (PLI)-** PLI became a new requirement for registrants with proclamation. All active MRT registrants were audited in January. Two were found not to be carrying proper PLI. They were contacted and issue was resolved. We are currently carrying out the same procedure for DMS registrants.



**Name in Registry-** This year it has come to our attention there are several individuals licensed under a name they use in practice that does not align to their official ID. The NSCMIRTP has a legislative responsibility to keep an accurate registry of registrants. This means the names in the registry must be verifiable as per 8(1)(c) of the NSCMIRTP Regulations.

All registrants who we do not hold government issued photo ID or it does not match the name on the register have been contacted by Joanne Jones Administrative Assistant requesting that photo ID be provided. Registrants can provide the ID in one of the following formats;

- uploaded directly to the secure registration platform or
- send by email to <a href="mailto:info@nscmirtp.ca">info@nscmirtp.ca</a> or <a href="mailto:joannejones@nscmirtp.ca">joannejones@nscmirtp.ca</a>
- send a good quality photo copy to NSCMIRTP offices
- arrange a virtual or in person meeting with the office where the ID can be shown to a member of staff.

Please note registrants that have received an email requesting photo ID must provide it in one of the above forms prior to renewal of license.

All requests for proof of identification have been sent via a legitimate NSCMIRTP email. Please do not ignore College requests. If you are unsure as to whether an email you receive from the college is legitimate, please contact us.

Registrants who initially applied after 2018 using the new online platform have already provided government issued photo ID as part of the registration process.

As the College is responsible for verification, we cannot delegate this responsibility to a third party such as the employer.

# **Registration & Renewal Guide Books**

The basic steps of the registration process is outlined on the College website. In an effort to assist applicants and registrants in having detailed directions and information related to registration and renewals the NSCMIRTP is in the process of developing guide books. They are expected to be available prior to renewal season and will be posted to the website.





# **Shielding requirements**

Some of you may have recently received a new position statement from the Canadian Association of Medical Radiation Technologists (CAMRT) on '<u>Discontinuing the Use of Gonadal and Fetal Shielding for Patients</u>'. While this position statement aligns with current practice for most MRTs in Nova Scotia it has created questions and conversation amongst many radiological technologists. In



line with the practice advisory question in this issue, it is important that all MIRTPs understand the roles of associations and regulators and how to best use practice guidelines put out by these bodies.

In this case for **Nova Scotia** MRTs there have been **no changes** to the provincial legislation or the NSCMIRTP Standards of Practice and MRTs must continue to comply with facility policies regarding the use of radiation protection devices, including shielding. Where appropriate it should be used to help inform change in worksite policy and practices, and standards of practice with the provincial regulator.
